



Warranty Transfer Application

For a transfer fee of **\$500.00 USD**, the Second Retail Purchaser may obtain a warranty for structural defects (the available warranty coverage period is the balance of 10 years from the date of the original purchase by the First Retail Purchaser); and factory installed non-structural parts and components (the available warranty coverage period is the balance of 2 years from the date of the original purchase by the First Retail Purchaser) subject to other terms, limitations, and exclusions of the Larson Boat Group (Larson, Striper and Triumph) Limited Warranty.

Written inspection by a current Larson Boat Group dealer or an authorized Larson Boat Group representative must accompany a Warranty Transfer Application form (attached below). The Warranty Transfer Application must be received by Larson Boat Group within 30 days of purchase by the Second Retail Purchaser.
